Cicada Brood XIV

If you live in the eastern United States, you may think of the drone of cicadas as the background noise of spring and summer. If you're not familiar, cicadas are a large and diverse group of sound-producing winged insects that emerge from the ground yearly or periodically. The popularly discussed periodical species emerge after 13 or 17 years underground. While they have one of the longest life cycles of insects due to their time spent underground, once they emerge they only live for a few days.

This year Brood XIV have emerged. They are a 17-year cicada and will mainly be seen in Kentucky and Tennessee. Cicadas begin to emerge once soil reaches 64 degrees Fahrenheit at a depth of 12-18 inches. Male cicadas emerge first, with females following just a few days later. When they leave the ground they will shed their shell and develop wings. The loud buzzing noise you hear is the mating call of the male cicadas. They have no natural inclination to fly away from predators, which is why they don't seem afraid of people.

Cicada emergences are greatly beneficial for other animals. Many animal species time their own reproduction with the cicadas, allowing them to feed even more of their young successfully than they might otherwise. Scientists can actually trace increases in other animal populations to the appearance of cicadas. Cicadas can also improve water filtration into the ground and aerate lawns.
